FAI Connect will now be used to track Club Mark applications and progress, in order for a club to apply through FAI Connect the associated club's "CLUB MANAGER" (FAI Connect admin) must have the user role "CLUB LICENSING CLUB RESPONSIBLE" assigned to their FAI Connect profile.
